Resolution

(i) Item No. 47.03: For the work of construction of Approach Road and Footpath for newly constructed Rail Underpass, R.C.C Retaining wall, Service road, Drainage, Storm Water drain, the proposal has been submitted for consideration under HEFA. The Finance Committee was apprised about the urgent requirement of underpass connecting the academic and residential campus of the Institute.
