At present, the vacant posts in the Institute has been advertised through Advertisement No.06/2019, dated 28.08.2019, the same is under process and is delayed due to COVID-19 pandemic.
(c)	the measures taken by the Government to fill up the vacant posts in the Central Government Services and educational institutions in a time bound manner for reserved categories i.e. OBC, SCs and STs; and	In case of Non-Teaching Recruitment the recruitment could not be made due to non-availability of Recruitment Rules except under PwD & SC. Now, the Recruitment Rules is available, therefore the recruitment process has been initiated vide advertisement No. 05/2019, dated August 23, 2019 for filling up of vacant posts. The same is under process and is delayed due to COVID-19 pandemic.





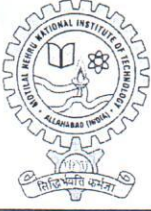
