
Concerns due to shutdown of educational institute		
Sl. No.	Particular	Reply
a.	whether with extension of shutdown of educational institutions till the end of September, 2020 the academic session 2020-21 has lost nearly 6 months;	No. MNNIT Allahabad conducted online classes for remaining syllabus from April 2020 to June 2020. Final year examination for 2019-2020 batch was conducted online. Not even a single student was absent in any of the examination. New semester has already started from 10th August 2020 in online mode. All teachings are being done in this mode.
b.	if so, plans by the Ministry to manage completion of syllabus within the available few months;	Not applicable. In the Institute, online classes are successful with complete use of IT-technologies. The Institute is extensively using Moodle, MS-Team and Webex for the purpose. As online teaching is continuing and all Heads of the department, Dean (Academic) and Director are regularly interacting with students and resolving all the relevant issues.
c.	whether online classes are also only for 2-3 hours and very limited subjects can be taught in these hours and there are no practicals for students which hampers science students; and	No. Online classes are being conducted as per full time table (nearly of 8 hours per day). The practical's is being conducted through Virtual labs/ Simulators. Practical's are demonstrated to students through online mode and video presentation prepared by the faculty. Also, Students in the practical classes can note readings of experiments, interact live with faculty and discuss their problems online.

a.	whether the Ministry will consider starting, at least higher classes to begin with and subsequently the other classes?	Ministry of Health & Family Welfare, Directorate General of Health Services, Gol vide letter dated 08.09.2020 has provided SOP on preventive measures to contain spread of COVID-19 in skill or entrepreneurship training institutions, higher educational institutions conducting doctoral courses and post graduate studies in technical & professional programs requiring laboratory /experimental work.


