Resolution

The Board of Governors considered the proposed action to be taken by the Institute on the clarification received from Ministry of Education regarding protection of pay of Assistant Professor (Grade-II) in MNNIT Allahabad vide letter No. F. 2-11/2023 TS.III dated 10.10.2023.

In the matter the Board of Governors was apprised with the following:

(i) The internal candidates who were working as Assistant Professor (Grade-II) (on contract) in the pay level 10 (AGP-6000) and after recruitment process of 02/2022 dated 24.05.2022 were placed as Assistant Professor (Grade-II) (on contract) at

- pay level 11 (AGP 7000) were drawing salary lesser than that they were drawing at AGP-6000 earlier. It resulted in dissatisfaction among such internal faculties and they have requested to resolve the issue of mapping of their basic pay at appropriate cell of AGP-7000/-.
- (ii) Accordingly, the matter was placed before the Board of Governors in the Seventy-second [72nd] meeting held on 31.03.2023, vide item No. 72.06 [B], wherein the Board resolved that there are no provisions of pay protection for the contractual positions therefore the request of newly appointed Assistant Professors at pay level 11 is not admissible.

Also, directed the Institute to explore what other NITs are doing in such cases.

- (iii) Accordingly, as desired by the Board, the Insitute has requested all other NITs & IIEST Shibpur to provide information regarding pay being offered to new faculties recruited as Assistant Professor (Gr-II) on contract at AGP 7000/- (7th CPC Pay Level 11).
- (iv) On perusing the reply of the other NITs it has been observed that they have fixed the pay of Assistant Professor (Grade-II) (On Contract) at pay level 11 by granting one increment in their pay at pay level 10 of 7th CPC Pay Matrix of faculty and fixed in the corresponding next higher cell at Pay Level 11 in the Pay Matrix in accordance with F. No. 15-4/2017-TC, dated October 27, 2017.
- (v) Further the matter was forwarded to Ministry of Education for framing a uniform policy across all NITs and in response Ministry of Education vide letter No. F. 2-11/2023 TS.III, dated 10.10.2023 has clarified the following:
 - "I am to refer to MNNIT Allahabad's letter dated 14.08,2023 on the above cited subject and to state that recruitment to the posts of faculties are to be done strictly as per the NITSER ACT and Statutes and guidelines issued by Government of India in this regard from time to time.
 - 2. In the present matter, the Institute is requested to resolve the issue at their level in line with the decision taken by their BoG or the criteria being adopted in majority of NITs. Institute is advised to take note that pay fixation of all these faculties may be carried out subject to audit objection, if any."
- (vi) Considering the Ministry of Education clarification, the Institute proposes that to

avoid any financial burden over the Ministry, salary of such faculty members may be mapped to equivalent cell of AGP-7000/-

In view of above, the Board considered and approved/confirmed the Institute proposal of mapping of pay of Assistant Professors (Grade-II) (on contract) in compliance of Ministry of Education letter No. F. 2-11/2023 TS.III, dated 10.10.2023.

Further, it was decided that the same shall be given to all Assistant Professors (Grade-II) (on contract) at AGP-7000/- from the date of their joining. The pay of such faculty members as approved by the Board is attached as **ANNEXURE-V**. The same policy will be adopted for all the Assistant Professors in AGP-7000/- recruited in the Institute.


