The Chairman, Senate extended warm welcome to the members and thanked them for taking their time out to attend the meeting.

The Senate also extended warm welcome to the new Registrar and Secretary, Senate, Col. Sanjiv Banerjee (Retd.) who was attending the meeting for the first time after his appointment as the Registrar of the Institute.

Agenda item-wise proceedings are as under:

Item No. 49.01 : **To confirm the minutes of the Forty-eighth (48th) meeting of the Senate held on 15.10 2014.**

Resolution : The Senate confirmed the minutes of its (48th) Forty eighth meeting held on 15.10.2014 with the following modification in respect of resolution on item No.48.03 (iv)

For:

"The Senate considered the request of Mr. Vivek Singh [2012PE02], for grant of

one month leave to complete his programme and resolved that he may be allowed for the same subject to the condition that he shall produce No Objection Certificate from his present employer to the effect that he shall be given six months leave by his employer for the purpose. Further, the Senate took a serious note on the unsubstantial allegation made by him in the statement that the Convenor, DMPC has given him assurance that he shall be granted one month leave. The Senate resolved that a warning letter be issued to the student in this regard."

Resolution : The Senate noted the action taken on the decisions taken in its Forty-eight (48th) meeting as circulated.





Resolution : The Senate considered the following matters with the permission of the Chairman, Senate


