
The Chairman, Senate extended warm welcome to the members and thanked them for taking their time out to attend the meeting.

Item No. 46.01 : **To confirm the minutes of the Forty Fifth [45th] meeting of the Senate held on 10.10.2013.**

Resolution : The Senate confirmed the minutes of its Forty Fifth [45th] meeting held on 10.10.2013, with the following observations:

- (i) **Item No. 44.09 [a]** : The Senate considered the letter from Prof. P. K. Dutta, member of the Senate in respect of his comments on item No. 44.09 [a] [A] [i], and after detailed deliberations, the Senate resolved that Dr. Joydeep Dutta, IET Raipur be included as a co-supervisor of Ms. D. Archana [Reg. No. 2009RCY01], a Ph. D. student of the Department of Chemistry from the date of submission of NOC from his organization as well as all other documents required as per Senate resolution No. 44.09 [a] [A]. The Senate further resolved that other similar cases may be put up before the Senate on case to case basis with all details.
- (ii) **Item No. 44.05[e]**: The name of the student at Sl. No. 02 may be read as "**Mr. Aniruddha Narain**" in place "**Mr. Aneruddha Narain**", which has appeared inadvertently.



Item No. 46.05 : **Any other item with the permission of the chair.**

Resolution : (i) The Senate considered the letter from Dr. Jayanti S. Rai, IAS, Commissioner, Technical Education, Commissionerate of Technical Education, Gandhi Nagar, Gujarat regarding earmarking five seats each in M. Tech. & Ph. D. Programmes in Civil, Electrical and Mechanical Engineering streams for the engineering faculty from Gujarat to be sponsored by the Government of

Gujarat, and resolved that such students may apply against the seats already earmarked for sponsored candidates in the Institute. The same may be informed to the Commissioner, Technical Education, Gujarat.

- (ii) The Senate considered the request made by Mr. Vivek Kumar Tripathi [Reg. No. 2008RMS09] a Ph. D. student of the School of Management Studies for continuing in the program and resolved that Mr. Tripathi be allowed to continue in programme till the end of the next semester. His further continuation in the programme shall be subjected to his satisfactory performance during this period.
- (iii) The Senate considered the recommendations of the Committee constituted vide notification No.774/Reg. Off./2013, dated 02.08.2013, as per the decision of the Senate taken in its Forty Fourth [44th] meeting held on 12.06.2013 in the matter of Mr. C. N. Singh [Regn. No. 2008REE54] and resolved that Mr. C. N. Singh be allowed to continue in the programme. A copy of the recommendations of the Committee as considered by the Senate is placed here at **ANNEXURE – I**.
- (iv) The Senate considered the recommendations of the Committee constituted vide notification No.775/Reg. Off./2013, dated 02.08.2013, as per the decision of the Senate taken in its Forty Fourth [44th] meeting held on 12.06.2013 in the matter of Mr. Kamal Sharma [Regn. No. 2008RME04] and approved the recommendations of the Committee. Accordingly, Mr. Kamal Sharma be allowed to submit his Ph. D. thesis as per guidelines of the Ordinances for Doctoral Programme. - (c) The Senate considered the resolution of the SMPC regarding equal distribution of seats as well as increase in number of seats in each of the three M. Tech. Programmes of the Department of Electrical Engineering i. e. M. Tech. [Control & Instrumentation], M. Tech. [Power System] and M. Tech. [Power Electronics & ASIC Design]/[Power Electronics & Drives], and agreed to the same in principle. The Senate further resolved that the matter be put up before the Board of Governors for consideration.

- (e) The Senate considered the resolution of the SMPC regarding the request of Mr. Shambhu Sharan Singh [Regn. No.2012EL03], a student of M. Tech. [Digital Systems] for semester leave in the present semester [Odd Semester of 2013-14] on account of his joining the Indian Railways as Senior Railway Supervisor, and approved one semester leave to him for the Odd Semester 2013-14.
- (f) The Senate considered the resolution of the SMPC regarding the request of Mr. Dravit Rana [Regn. No. 2012VL13] a student of M. Tech. [Microelectronics and VLSI Design] for three months leave to work for his thesis as non-degree student at Apache Design Solutions, Noida. The Senate resolved that the Department may be advised that the student may be granted leave from time to time as and when required for the purpose since there is no provision in the ordinance to work in a non-academic institution for a long duration.
- (g) The Senate considered the resolution of the SMPC regarding the correction of marks distribution [from TA-20, MS-20, ESE-60 to TA-50



- (h) The Senate considered the resolution of the SMPC regarding the request of Mr. Ashish Raghuwanshi [Regn. No. 2011GI14] a student of M. Tech. [GIS and Remote Sensing], who has completed his III Semester in December, 2012 and after registering in IV Semester for thesis, he joined MPPKVV Co. Ltd. on 16.01.2013. He has requested for two semesters leave and wants to register in the Even Semester of 2013-14. The Senate resolved that the matter be put up before the Senate with full details.
- (i) The Senate considered the resolution of the SMPC regarding the stipend of two students of M. Tech. [GIS and Remote Sensing], Mr. Pankaj Rungta [Regn. No. 2011GI15] and Mr. Abhay Tripathi [Regn. No. 2011GI23] which was discontinued due to F grade in one of the subjects in their II Semester. Later in their IV semester they have taken parallel subjects and cleared the ACD. Now they have requested for stipend for the period between declaration of the result [22.05.2013] to the date of defense of their M. Tech. Thesis [28.06.2013], and resolved to turn down their request.





After going through the records available in the file of Mr. C. N. Singh following facts were found.


- Mr. C. N. Singh was registered in January- 2010 as Ph. D. Part Time sponsored candidate with registration number 2009REE54.
- Mr. C. N. Singh is working under the supervision of Prof. Dinesh Chandra (EED) and Dr. Rajeev Srivastava (MED).
- He completed his course credit requirement in the 1st Semester. He has completed his thesis performance of 88 credits till 6th semester of his Ph. D. programme with 4Xs.
- Mr. C. N. Singh applied for permission to appear in comprehensive examination on 11.06.2012 (end of fifth semester). As per record the letter was forwarded to Chairman – SPGC by Convener – DPGC on the same day.
- Latter query was raised by Chairman – SPGC regarding delay in conducting comprehensive examination which was supposed to be completed by **the end of the third Semester**. The reply of the queries from the Department was received to Chairman – SPGC on 22.08.2012 (Sixth Semester).
- The case of Mr. C. N. Singh was discussed in SPGC meeting which was held on 08.01.2013 and recommendation was made for consideration in Senate. In the 43rd meeting of Senate, the request of Mr. C. N. Singh and recommendation of SPGC was turned down. In the Senate meeting the Reg. No. of Mr. C. N. Singh was considered 2008REE54 on the basis of wrongly communicated registration number by the department from time to time through their DPGC meetings.
- The mistake of registration number as 2008REE54 was raised by the department in the 44th meeting of Senate. It was pointed out at the start of 44th meeting of Senate by the concerned supervisor and HoD.
- In 7th semester (Jan-13 to June-13) the grade of Mr. C. N. Singh (2009REE54) has been entered as ABS. Presently he should have been in 8th Semester from his first registration date.
- His maximum duration of Ph. D. programme will be completed by December- 2015.

In light of above facts and circumstances, the present committee recommends that the case of Mr. C. N. Singh (2009REE54) may be reviewed.


After going through the records available in the personal file of Mr. Kamal Sharma and additional document submitted by Dr. Mukul Shukla after previous meeting, following facts were found.


1. Mr. Kamal Sharma (2008RME04) was registered as Ph.D. student in July – 2008.
2. He completed 8 credit course work and 8 credit thesis performance in his first semester registration.
3. He completed his comprehensive examination in his 2nd semester on 12.05.2009 and accordinally his State of Art Seminar was due before 11.11.2009 (within six months from comprehensive examination).
4. Mr. Kamal Sharma wrote a letter to DPGC-MED on 29.10.2009 with a request to convert his full time (sponsored) status into part time status which was recommended & forwarded by his thesis supervisor on 03.11.2009. The letter was neither marked by DPGC or HoD nor there was any recommendation made from the department to SPGC for such conversion Records are not available related to any processing completed for conversion from full time to part time. The procedure of conversion as per clause 4.7 (1) was never completed. No effort was made either by student or by department to find it out about the status of conversion process.
5. In the mean time, Mr. Kamal Sharma delivered his State of Art Seminar on 16.02.2013 after taking permission of Chairman – SPGC on 02.02.2010 which was due before 11.11.2009.
6. His thesis supervisor, Dr. Mukul Shukla, Associate Professor MED, was on long leave from 01.03. 2010 to 31.12. 2012. During long leave period, no thesis coordinator was appointed which was required as per PG Manual clause 11.1 (a) (7).
7. Mr. Kamal Sharma delivered his Open Seminar on 28.06.2012 and report was sent to Chairman-SPGC on 11.03.2013.
8. Mr. Kamal Sharma has been registering in all semesters with 16 credit thesis performance from 5th semester to 10th semester with all satisfactory grades.
9. Mr. Kamal Sharma has completed 5 years in June – 2013.


As per records available in the file of Mr. Kamal Sharma (2008RME04), it has been found by the committee that procedure as per PG Manual were not followed for S. No. 4, 6, and 7, mentioned above. These were serious lapses at the part of student, Supervisor and DPGC. Now the student is ready to submit his Ph.D. thesis and hence, the committee recommends the following in the interest of student.

1. The student registration in his 11th semester starting from July – 2013 may be formalized valid.
2. He may be allowed to submit his Ph.D. thesis as per guidelines of new Ph. D. ordinance.

1. Regarding the evaluation of PG courses and thesis in the current semester and onwards, chairman apprised the members about the evaluation process as per the new ordinances. There was some confusion regarding award of W, S and X grades (as mentioned on page no. 18 of PG ordinances), for which the committee resolved to seek clarification form the senate.
2. Senate clarification is also required on maximum leave permitted to a stipendiary student in PG program (Item no. 5.1.2 of PG ordinances at page no. 13)
3. Redistribution of existing number of seats in the M. Tech program uniformly in three groups in EED
 - a. During P.G. courses restructuring and revision of curricula, It was proposed by the department as well as the external members invited in the P.G. Curriculum revision workshop, to modify the name of existing M.Tech. Program from Power Electronics & ASIC Design to Power Electronics & Drives.

Subsequently the modified curriculum was approved by senate and was implemented from session 2013-2014.

- b. Since last two years the existing strength of students in three courses running in the department are as follow:

Which is highly unbalanced, especially the thin strength of students in Control & Instrumentation, Also department has very strong group of Control & Instrumentation faculties.

Therefore, department has proposed that the existing sanctioned no. of total seats (Control & Instrumentation-20 + PE & Drive-31) = 51, may be equally distributed among three programs.

Further, if possible, it can be raised to 20 numbers of seats in each specialization (at par with other M. Tech. programs in the institute) and same may communicated to funding agency (AICTE/MHRD) as applicable .


4. **ECE Dept.-**Regarding the resumption of stipend of Mr. Poltluri B. Santosh Kumar (2012VL26), as he has completed CPI of 6.0 after his second semester and he is not having any subject with E and F grades.

5. **ECE Dept.-**Mr. Shambhu Sharan Singh (2012EL03), a student of M. Tech. (Digital Systems) has requested for a semester leave in the present semester (odd sem of 2013-14) because he has joined Railways as Sr. Railway Supervisor and going through the training. DMPC has recommended his semester leave.
Committee resolved to put the matter before senate for permission for one semesters leave in the current semester.
6. **ECE Dept.-** Mr. Dravit Rana (2012VL13) student of M.Tech. (Microelectronics and VLSI Design) has requested for three months leave to work for his thesis as non-degree student at Apache Design solutions, NOIDA. Mr. Rana has completed his two semester course work and his current CPI is 8.94. and II semester (course sl. no. 4), as reported in the PG ordinances (page no. 44), Committee resolved to seek the permission of senate for the required modification.



Latter in their IV sem they have taken parallel subjects and cleared the ACD. Now they have requested for stipend for the period between declarant on of result (i.e. 22/05/2013) till date of defense of their M.Tech. Thesis. (28/06/2013) Committee resolved to put the matter before the senate for guidance as the ordinance is silent on the issue.
10. Applied Mechanics Dept.-Regarding the recommendation of DMPC for termination of Mr. Gaurav Yadav (2012BM12) as he is absent from the department since 05 Sept 2013, without any information to supervisor/dept. He has neither applied for any leave nor responding to the letter issued by dept. in that regard. Committee approved the termination of Mr. Gaurav Yadav (2012BM12) from the program.


