The Director welcomed the Chairman and the members of the Board and thanked them for taking time out to attend the meeting. The meeting started with the remarks of the Chairman with the initial observations.

- Chairman expressed his appreciation for holding of the convocation held on 3rd Nov, 2004. He congratulated the Director and his team for the excellent organization of the convocation.
- Chairman took up the case of resignation rendered by Prof. I.K.Bhat, Dean Administration. The members were unanimous in rejecting the request of Prof Bhat and decided that he be asked to continue.

The Board deliberated upon the agenda items of its fifth meeting and took the following decisions:

5.01 To consider the minutes of the 4th meeting of the Board of Governors held on 04.05.2004.

The Board of Governors considered the draft minutes of its 4th meeting held on 04.05.2004 and confirmed the same.

5.02 Action Taken Report on the decisions taken in the 4th meeting of the Board of Governors held on 04.05.2004

The Board of Governors considered the Action Taken Report of the Institute on the decisions taken in the 4th meeting of held on 04.05.2004 and noted the same.

5.03 To ratify the following approvals given by the Chairman, Board of &5.17 Governors

The Board noted the approvals given by the Chairman, BOG on the following matters and ratified the same.

- Approval of the recommendation of the Screening Committee for continuance of certain Non Teaching Staff up to 60 year of age.
- Approval of the merger of 50 % Dearness Allowance (DA)/ Dearness relief with basic pay/pension.
- Approval of the recommendation of the Selection Committee for promotion under CAS.
- Approval for the adoption of New Pension Scheme.
- Approval of the confirmation of the Faculty and Administrative Staff on completion of probationary period.
- Approval of the appointment of Dr. Anil Kumar as Visiting Professor in the Department of Physics.
- Approval for the appointment of the Legal Consultant Sri R. B. Singhal.
- Approval for appointment of Institute Affairs Sub Committee of the Board

5.08 To reconsider the case of compassionate appointment in the Institute.

The Director explained the reason for listing this agenda item once again. However, the Board again turned down the proposal. On the insistence of the Director it was decided that all such cases should be referred to the ministry for consideration.

5.09 To consider the requirement of faculty positions and recruitment of faculty.

The Board directed the institute to initiate action in this regard to fill all the vacant positions. It also suggested that the present and future requirements should be worked out so that the same could be sent to MHRD for consideration. A complete Faculty position requirement should be put before the Board in its next meeting.

5.10 To consider the sanction of certain service benefits e.g. overtime allowances and advances for the employees of the Institution.

The MHRD representatives did not agree with the proposal. However, after subsequent deliberations it was decided to refer the same to Ministry of Human Resource Development for consideration.



5.11 To sanction the expenditure for various developmental activities under the Plan fund for the Financial Year 2004-2005

The Board noted the details and approved the estimated expenditure

5.12 To consider the representation of Dr. S. N. Pandey, Lecturer in Department of Mathematics for grant of Lecturer Senior Scale, Lecturer Selection Grade/Reader and promotion as Professor under Career Advancement Scheme.

The Board considered the representation of Dr. S. N. Pandey and turned down his request.

5.13 To consider the representation of Sri A. C. Agarwal, Lecturer in Mechanical Engineering Department for promotion under Career Advancement Scheme as Lecturer Senior Scale, Lecturer Selection Grade as Reader and Professor

The Board considered the representation of Sri. A. C. Agarwal and turned down his request. It decided to withdraw the offer of promotion made to him as he has declined to join as Lecturer in Senior Scale.



5.15 To consider the appointment of a Legal Consultant for Institute Matters.

5.16 To consider the merger of Department of Humanities and Social Sciences in School of Management Studies and renaming the merged department as Department of Management and Social Sciences

5.20 Approval of the Annual Accounts, Balance Sheet of the Institute for the Financial Year 2003-2004.

The Board noted the position of Annual Accounts, Balance Sheet of the Institute for the Financial Year 2003-2004 and approved the same.

5.21 Ratification of Furnishing carried out in the Director's Residence

The Board reposed its confidence in the Director and ratified the works and furnishings already undertaken. It authorized the Director to judiciously complete the refurbishment and furnishing of the Directors residence in manner befitting the stature of his position.

5.22 To consider the proposal for hiring Technical persons for Lab and Academic Supporting Staff through contractors.

The Board approved the proposal for selection of these key persons (not more than 15) and recruit through labour contract for a semester i.e. 90 days in the first instance and if required after break of one day for hiring them upto the end of the semester. As desired by MHRD representatives it was decided to send the detailed proposal to MHRD within forty five days.
